Hello Team,

In preparation for the Love Bug Boogie Dance on February 15th, 2025 we have a few things that we need to vote on.

#### 1) Motion 1: 50/50 Raffle

We are planning on having a 50/50 raffle again this year with the proceeds going to playground additions/ expansion at JDES. Ellen will get the 50/50 License. We will sell tickets for \$2/each and will have a total of 660 tickets to sell. Winner drawn will take home 1/2 of the funds generated by the 50/50.

I, Brandi Filipchuk motion to have a 50/50 raffle at the Love Bug Boogie Dance on Saturday February 15th. The proceeds will go towards playground additions/ expansion at JDES. Tickets will be sold for \$2/each and there will be a total of 660 tickets available for purchase.

#### 2) Motion: Floats for the Dance

This year we will need floats at the food table, the 50/50 table, the merchandise table and then a small float of \$5 bills at the registration table- so 4 total. We only have 2 cash boxes, but the Optimus Club will let us borrow one of theirs. We will need 3x \$250 (various bills/ change) cash floats and then \$100 worth of \$5 dollar bills for the registration table; I will keep that amount in my crossbody bag (on me) at the entrance.

I, Brandi Filipchuk motion to withdraw a total amount of \$850 from our Fundraising Account for 4 floats- (3x \$250; various bills /change) & (1x \$100; \$5 bills) for the dance. These funds will be returned/ replaced after the dance back into the Fundraising Account.

#### 3) Complimentary Dance Tickets for families in need at JDES

In previous years we have provided tickets (maximum of 20 tickets @ \$5/each) to the administration at JDES to give to families that would like to attend the dance, but might not be financially able to purchase tickets. Kory & Susan are working on a list of who they think would like to attend and will reach out to those families, so that it remains confidential. Once they reach out to the families, I will purchase the tickets and then give them to the school to distribute. I will be reimbursed out of the Fundraising Account upon providing receipts for tickets purchased for the event to Ellen.

I, Brandi Filipchuk motion to spend a maximum of \$100 (or 20 tickets) for the Love Bug Boogie Dance from our Fundraising Account to give to the Administration at JDES to give to families in need at JDES, so they can attend the dance.

Happy Friday Everyone!

I was speaking with Ellen earlier today- we discussed the easiest way to process/ track and distribute the Discount Cards. My plan is to pick the money and order forms up from each school on Friday's (at the end of the day) and then process them, so that they are ready to distribute on the following Monday. Ellen has created a 'Master' spreadsheet that will be separated further into the 2 different schools for tracking purposes.

We also discussed that we will need to purchase envelopes to distribute the cards to the families- we don't want them getting misplaced or lost. A copy of the order form will also be included with the cards, so it's easy for the families to distribute the cards to those that purchased them. The expense for the envelopes can come out of our Fundraising Account; but will be reimbursed out of the profit from the card sales once the fundraiser is complete.

Therefore, I motion that we purchase envelopes for the distribution of the Discount Cards. This amount should not exceed \$100.00 and will be reimbursed out of our fundraising account. I will purchase the envelopes (based on demand) and then submit my receipt(s) for reimbursement. At the end of the Discount Card Fundraiser the cost of the envelopes will be deducted from the total profits from the Fundraiser and then deposited into our fundraising account; with the remaining profit going to the playground.
